Welcome Address

2023 Overview



2023 was marked by the **relocation of our facilities to the Iscte - Knowledge and Innovation (CVTT)** building – a state-of-the-art infrastructure that houses Iscte's research services. We took this change as an opportunity to encourage our work and make steady growth a strategic priority under the motto of digital transformation.

We are proud to celebrate our continued efforts in promoting the **EUR 933 thousand** from competitive calls, securing in particular **3 FCT Scientific Employment contracts, 2 individual junior researcher contracts** and **1 institutional contract** with the SocioDigital Lab for a new Data Science researcher.

It was a fulfilling year as we advanced our mission of conducting excellent research, delivering world-class doctoral training, and actively engaging with society on widely relevant topics.

One especially noteworthy achievement was the publication of the White Paper “*Where to Publish? Where not to Publish?*”, which directly impacted Iscte’s in-house policies at the Rectorate level. This publication was able to bridge a chasm between research and practice and influence issues on publication ethics, raising Iscte’s standards to international practices.

Another memorable accomplishment in 2023 was the 10th Responsible Management Education Research (RMER) Conference, co-organised by BRU-Iscte in partnership with Iscte Business School and Audax-Iscte. The three-day event took place between September 26-28, at Iscte, marking the 10th jubilee anniversary of RMER Conferences.

Throughout the year, researchers from around the world have both awed and enlightened us – and our own were no exception. Sandra Loureiro and Fernando Ferreira were ranked among the 2% most influential scientist in their respective fields by Stanford University, attesting to the high quality of BRU-Iscte’s scientific production.

2023 was a productive year, with an output of over **370 peer-reviewed publications** – from books to book chapters, journal articles and papers in conference proceedings –, and over **200 dissemination activities** – from summer schools to media outreach, non-academic engagement, and other knowledge transfer activities.

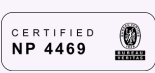
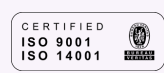

News about BRU-Iscte Activities



Inauguration of the Iscte Knowledge and Innovation building complex (Iscte-CVTT)

The new Iscte-CVTT building complex houses Iscte's research facilities, which comprise eight research units (including BRU-Iscte) as well as several laboratories and observatories, with the aim of providing integrated knowledge transfer solutions for society, organisations, companies, and public administration. The sustainably renovated construction is equipped with multifunctional modular spaces to promote a collaborative environment in which researchers, students, teachers, citizens, and other stakeholders feel welcome. The building complex was inaugurated on **November 20, 2023**, by the Prime Minister António Costa with the presence of the several other ministers and members of the Government, as well as other esteemed guests.



As part of the occasion, Iscte organised a Science and Technology Day, in which the community, key partners, and stakeholders were able to visit the facilities and get to know ongoing projects.

During the guided tour, BRU-Iscte's involvement was showcased through various projects: UAMSchool4cities (Erasmus+ initiative led by BRU-Iscte) was introduced by PI **Sofia Kalakou**; EMPOWER (EU project) was presented by local coordinator **Aristides Ferreira**; RESETTING (EU project) by **Sandra Loureiro**; SmartVitiNet (EU project) by **Sofia Kalakou**, **Margarida Lopes** and **Helena Almeida**; AMR-Educare, (EU project) by **Ana Lúcia Martins**; and kNOwHate (EU project) by BRU-Iscte staff member **Andreia Garcia**, who serves as the project's communication manager. Additionally, BRU-Iscte's involvement in the completed DeSTRESS Erasmus+ project was highlighted by PI **Sílvia Silva** and team members **Ana Patrícia Duarte**, **Francisca Carvalho** and **Francisco Delgado**. Other projects featuring BRU-Iscte's participation, namely XpanDH (EU project led by **Henrique Martins**) and Coop4Int (international project co-coordinated at Iscte by **Maria José Sousa**), were also showcased.

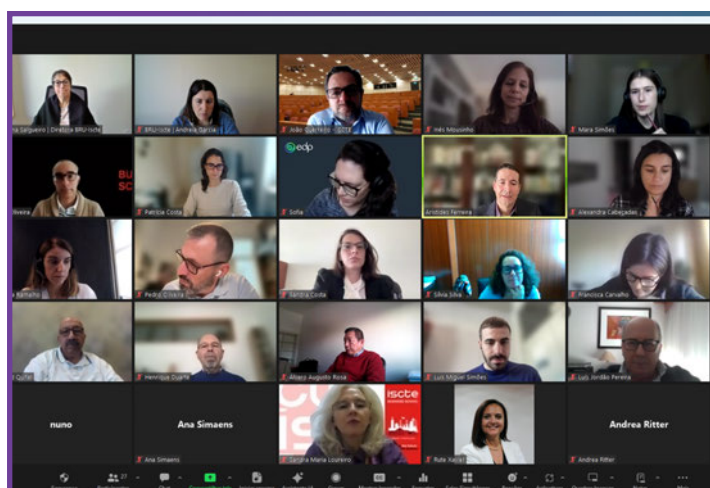


During the open day, representatives from the Portuguese energy company EDP visited Iscte-CVTT facilities and were greeted by BRU-Iscte Director **Fátima Salgueiro** and Deputy-Director **Jonas Oliveira**. BRU-Iscte technological start-up partner EIKKO was also represented at this Open Day.

The event counted with the invaluable support from COM'Investigar, the group of science communication managers from the different Iscte research units, of which BRU-Iscte staff members **Andreia Garcia** and **Cheila Ramalho** are a part.

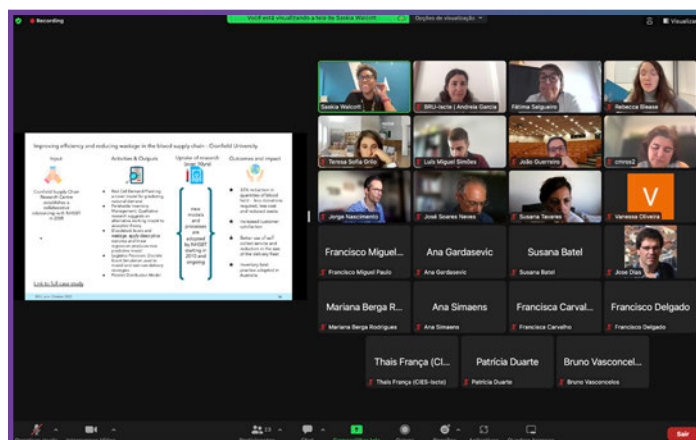
R&B Talks

In 2023, BRU-Iscte launched an initiative to narrow the gap between academic research and business practice: the R&B (Research and Business) Talks. This platform facilitates a collaborative environment where researchers offer scientific insights that can help deal with managerial problems, and companies present challenges for researchers to address. The inaugural R&B Talk happened on **November 7, 2023**, and featured a pairing between BRU-Iscte and EDP to develop a data-driven culture at the company.



Workshops on Research Impact

In 2023 BRU-Iscte invested in training activities to help its researchers improve their skills and maximize the impact and outreach capabilities of their research. As part of that effort, the research unit organised two workshops presented by **Saskia Walcott**, Chief Executive of WCL – a UK-based specialist research impact consultancy. On **October 4, 2023**, BRU-Iscte offered the webinar “A short introduction to achieving (positive) change through academic research”. This webinar offered an introduction to the concept of valorisation, outlining the meaning of ‘impact’ and the reasons it has become an area of activity that academics must now understand and consider as part of their research planning. It showcased examples to illustrate the variety of impact that is possible from business research through mechanisms such as public engagement, policy engagement and business consultancy.



On **October 20**, 2023, BRU-Iscte offered the workshop “*How to progress your research towards societal change*”. BRU-Iscte researchers in attendance were tasked with devising strategies to align their research with positive societal transformation. Throughout the session, participants navigated various exercises aimed at identifying potential beneficiaries of their research and establishing collaborative partnerships essential for fostering impactful change. Additionally, they contemplated ideal collaborators and reflected on practical and epistemological challenges of impact engagement.



Workshops on Science Communication

Between **November 20** and **24**, 2023, Iscte Knowledge and Innovation (Iscte's valorisation centre) and SocioDigital Lab for Public Policy (FCT associate laboratory led by Iscte) jointly organised the Science and Technology Week 2023. This occasion was centred around the reflection and discussion on the current and future states of science and technology through various activities, including workshops and information sessions.

As part of this event, on **November 22**, BRU-Iscte organised a workshop for its researchers on science communication around the theme of "*demystifying science*". The workshop ran with two operating prompts: "*how to write a press release*" and "*media interviews*". The activity was hosted by **António Granado**, professor at NOVA University of Lisbon, School of Social Sciences and Humanities, and journalist **Vasco Trigo**.



Researchers Involved in Iscte Spin-offs

FutureCast Lab

On **April 20**, 2023, the Management & Marketing FutureCast Lab hosted the conference "*How AI (Artificial Intelligence) is Changing Management*". This hybrid event was held at Iscte and streamed through YouTube, delving into the impact of AI-based technology on organisational innovation. Over 400 people attended in person and online. BRU-Iscte's researcher and Deputy Director **João Guerreiro** gave a presentation on how teaching must adapt to a new reality resulting from the democratisation of generative AI tools such as ChatGPT. BRU-Iscte researcher **Pedro Dionísio** led the panel discussion in the second part of the event, probing the theme of "*Experiences and Expectations*", exploring the future direction of AI.



SocioDigital Lab for Public Policy

The thematic lines (TLs) of the FCT associate laboratory SocioDigital Lab for Public Policy (SDLab) underwent some updates in 2023. The BRU-Iscte co-coordinator of TL1 “Regenerative Territories for Carbon Neutrality”, **Catarina Roseta Palma** stepped down, being replaced by **Mónica Meireles** (both researchers from the Economics group). In addition, TL3 “Societal Health” integrated the work of Iscte Health – a transversal initiative from Iscte with a cross-disciplinary intervention span (social sciences, technology, and management) – and gained a new co-coordinator, BRU-Iscte researcher **Henrique Martins** (Management research group).

Later in the year, the SDLab hosted its 2nd conference on **November 28 and 29**, under the theme “*Inclusive Territories for the Green and Digital Transition*”. The event took place in the newly inaugurated Iscte-CVTT building complex and was co-organised by BRU-Iscte researcher **Mónica Meireles**, together with Assunção Gato (DINÂMIA’CET-Iscte) and Susana Batel (CIS-Iscte) – co-coordinators of SDLab’s TL1. BRU-Iscte researchers **Henrique Martins** and **Catarina Roseta Palma** participated in the moderation and in the round table discussions, “*A space for age: more sustainable, inclusive and healthy cities*” and “*Inclusions and transitions: the cross-cutting challenges*”, respectively.

The conference organisation was supported by COM’Investigar, the group of science communication managers from the different SDLab research units, of which BRU-Iscte staff members **Andreia Garcia** and **Cheila Ramalho** are a part.



Research Impact and Alignment with the Sustainable Development Goals (SDGs) III

Through its Sustainability Policy, Iscte recognises (and regulates) its responsibility as a higher education institution to contribute to the SDGs defined by the 2030 Agenda. Specifically, Iscte aims to promote research activity that operationalises the achievement of the goals. For example, the institution allows its researchers to link specific SDGs to their scientific output, whenever they submit an entry in its proprietary information system Ciência-IUL, giving the goals visibility and relevance.



Following the practice of previous years, we asked our researchers at BRU-Iscte to identify the SDGs most relevant to their scientific output, both through Ciência-IUL and through questionnaires. The virtues of this exercise are twofold: it makes researchers reflect upon the goals in connection to their work, and it allows us to map the research unit's scientific production in terms of its overarching foci.

For the year 2023, BRU-Iscte researchers have listed **137 scientific communications**, **167 publications** and **28 projects** having contributed to the SDGs. In addition, our researchers reported **63** doctoral theses concluded in 2023 (PhD and DBA programmes), also contributing to the SDGs.

Following our mapping exercise, we can conclude the following alignment in 2023:



As advocated previously, BRU-Iscte is working on building its interdisciplinary capacity by exploring research trends anchored on the Sustainable Development Goals within each research group and in transversal thematic lines.

BRU-Iscte Team 2023



By the end of 2023, the BRU-Iscte research team comprised **184 members** (including 151 PhD holders) spread out through **7 research groups**: Accounting (17 members); Data Analytics (21 members); Economics (25 members); Finance (18 members); Management (38 members); Marketing (29 members); and Organizational Behavior & Human Resources (36 members). Among these, **99** were integrated members, **52** were associated members, and **33** were research assistants (mainly PhD candidates). In addition, the BRU-Iscte research unit operated with an administrative staff of **five** members.

Finally, I would like to thank the Accounting Department at Iscte Business School for their welcome."*

Scientific Programmes & Activities

Funding Sources

In the year **2023** the funding sources for BRU-Iscte's research activities were more diversified than ever before. Noticeable was a dramatic rise in funds obtained from competitive European projects, including Horizon Europe and other EU programmes.

These results were achieved with essentially the same number of researchers and support staff, which clearly indicates increased productivity levels and a deeper involvement and visibility in international networks, through research consortia. The results may be leveraged in the coming years to attract renewed funding, top researchers and fellowships and lead to top publications and other excellent research outputs and dissemination activities.

Advanced Training

BRU-Iscte coordinates three PhD programmes in Management, Finance, and Economics, the latter in collaboration with Iscte's research unit DINÂMIA'CET. Concurrently, BRU-Iscte offers a Doctor of Business Administration (DBA) programme, in collaboration with Chinese universities accredited by the Chinese Ministry of Education.

In 2023, a total of **63** candidates have graduated from one of these doctoral programmes (**16** from the PhD programme and **47** from the DBA programme) under the supervision of BRU-Iscte integrated or associated members. In addition, these members also supervised **4** additional PhD theses from doctoral candidates of other universities.

Besides being involved in the supervision of doctoral theses, BRU-Iscte members have directly supervised **386** MSc dissertations and **97** MSc final projects, defended in 2023.



Research Fellowships

In 2023, BRU-Iscte secured funding from various sources for new fellowships supporting **9** doctoral students, **4** MSc students, and **2** post-doctoral researchers.

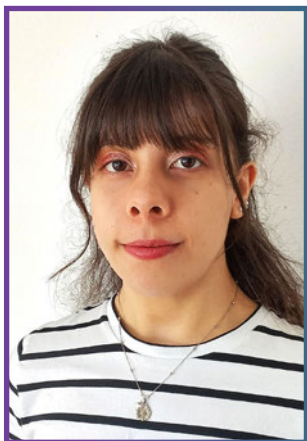

Research Projects

Submitted & Approved Applications

BRU-Iscte actively seeks diverse pathways for research funding to strategically position itself and broaden the sources of its financial support, with a strong focus on internationalisation.

With the help of a highly qualified staff, BRU-Iscte researchers are finding and leveraging funding opportunities more effectively, making efforts to prepare and submit quality applications.

In 2023, BRU-Iscte researchers **submitted** a total of **32 applications** for national and international funding, with a 22% success rate in international calls and 44% in national calls. In terms of amounts, the research unit was able to secure over **EUR 933 thousand** from competitive calls, which constitutes a decrease from 2022, a particular successful year in approved projects, which can be partially explained by the increased number of research contracts to manage in 2023 and thus less time to dedicate to pre-award activities.



New Projects in 2023

International



INITIATE: Supporting European R&I through stakeholder collaboration and institutional reform (European project – HORIZON Coordination and Support Action)

INITIATE was approved in 2023 and is expected to run between February 2024 and July 2027, under the coordination of the University of Zagreb (Croatia). BRU-Iscte researcher **Paula Vicente** is the local coordinator, and researchers **Abdul Kadir Suleman** and **Elizabeth Reis** are part of the team. The project also includes Iscte research units ISTAR-Iscte and DINÂMIA'CET-Iscte, showing its reach throughout diverse fields of knowledge. The project aims to empower Higher Education institutions to develop R&I through a co-design approach with various stakeholders. This approach comprises taking stock of the current needs and resources of the institutions and of external elements such as policy barriers. In addition, possible collaboration areas with other establishments including local ecosystems will be identified, and good practices from other initiatives will be compiled. INITIATE aims to generate policy recommendations, resulting in a roadmap for long term uptake of R&I in widening countries. The project will also result in the creation of a pilot Big Data & Business Analytics Lab.



xShare: Expanding the European EHRxF to share and effectively use health data within the EHDS (European project – HORIZON Research and Innovation Action)

xShare is a new Horizon Europe project and is expected to run between December 2023 and November 2026, under the coordination of MEDCOM (Denmark). BRU-Iscte researcher **Henrique Martins** is the local coordinator. In addition to BRU-Iscte, three other Iscte research units are involved in the project's team – CIS-Iscte, CIES-Iscte, and ISTAR-Iscte –, showcasing the multidisciplinary involvement of our institution and the broad scope of knowledge of the research team.

The project aims to establish a Standards and Policy Hub for the EEHRxF (European electronic health record exchange format) in partnership with key organisations and market actors supported by competence centres, nationals and regional authorities, and European SMEs. xShare envisions everyone sharing their health data with a click-of-a-button and having the xShare button featured across health portals and patient apps. As a result, EEHRxF will be the driver for research and innovation in the European Health Data Space, allowing people to exercise their data portability rights.



SMITour: SMart Industrial Tourism in the Mediterranean (European project – INTERREG Euro-MED)

Financed in 2023 and set to run from January 2024 until March 2026, SMITour is coordinated by the municipality of Prato (Italy) with BRU-Iscte researchers **Maria José Sousa** and **Álvaro Dias** as part of the research team and local co-coordinators. Through transnational cooperation, SMITour aims to explore the social and economic potential of Smart Industrial Tourism (SMIT) as a sustainable economic activity that can benefit tourism actors, SMEs, industry experts, Chambers of Commerce and Industry, R&D centres, Higher Education institutions, technology providers, and local communities. The project will create transnational working groups involving 4-helix stakeholders to define a common strategy and Action Plan for the development of SMIT in the Mediterranean regions, contributing to the academic understanding of the topic. The result will be a diversification of the economy and of the sector, a reduction of over-tourism and seasonalisation, and a boost to social and economic growth and to technological innovation of tourism at large.



STUDIES-DIG: Models and instruments for transforming Higher Education systems through transnational multi-sector links (European project – HORIZON MSCA Staff Exchange)



Led by the University of National and World Economy (Bulgaria), STUDIES-DIG was approved in September 2023 and is programmed to run between January 2024 and December 2027. BRU-Iscte researcher **Maria José Sousa** is part of the research team.

The project also involves other Iscte research units – CIES-Iscte (local coordinator), ISTAR-Iscte, and DINÂMIA'CET-Iscte –, demonstrating a wide and multidisciplinary scope of action. The project brings together European, Asian, and African academic and non-academic organizations in a staff exchange program, with the goal to explore, design, and deploy innovative and context sensitive solutions to transform Higher Education systems. The aim is to research and identify successful contemporary models and instruments that support the sustainable and effective adaptation of the Higher Education systems of the consortium members to the digital age. Based on the identified gaps in the digitalisation process, the project will propose approaches and methodologies which will be realised as different disciplines for the academic institutions' partners to build sustainable



ESIF.COM-BOOST: Valor público e boost comunicacional dos fundos Europeus [Public value and communication boost of European funds]

Secured in 2023 and set to run from February 2024 until May 2024, the ESIF.COM-BOOST project is a project funded through Portugal2030 programme with the support of European structural funds.

The project is led by Iscte (coordinator is Sérgio Caramelo from DINÂMIA'CET-Iscte), with the participation of BRU-Iscte researchers **Nelson Ramalho** and **Teresa Almeida**, as well as from CIES-Iscte. This project aims to reduce the limited knowledge that European citizens – and the Portuguese, in particular – have about European funds and their impact. It proposes to identify the most appropriate communication strategies for strengthening and affirming the public value of these financial instruments, specifically pointed to media professionals and to the knowledge and skill gaps in this field. In addition, it proposes to identify action proposals related to the media ecosystem that seek to empower audiences directly.



SUSPITALITY/CiTUR: A socio-technical approach to sustainability determinants in the hospitality sector in Madeira

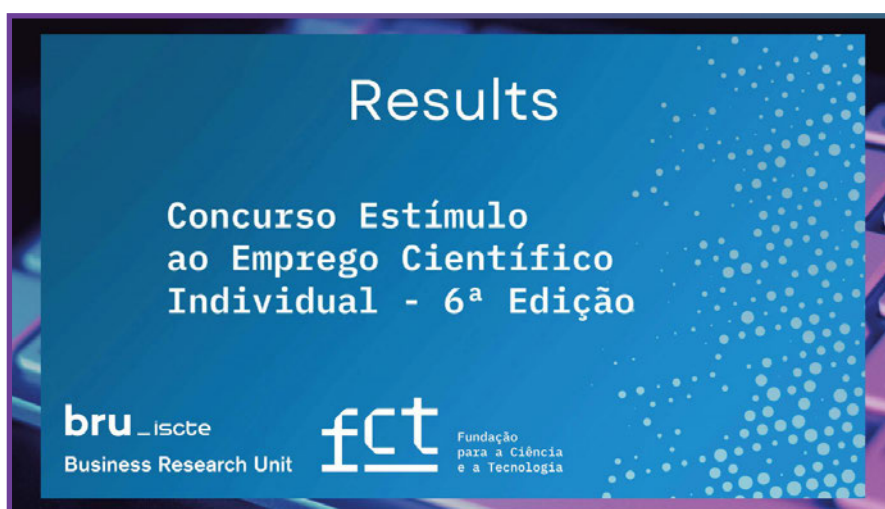
Led by University of Madeira's CiTUR research centre, the SUSPITALITY project aims to study the sustainability determinants that impact business performance in Madeira's hotel sector – considering both the abundance of decision-makers with conflicting values and preferences involved, and the large number of sustainability determinants to be considered. A better understanding of the ways in which they are interconnected will help decision-makers create value through more informed decisions, while at the same time advancing sustainability goals. The first phase of the project initiated in December 2023 and the whole undertaking is expected to run until December 2024. Two BRU-Iscte researchers are part of the project, **Fernando Ferreira** is the project's Scientific Coordinator and **Alexandra Milici** is part of the research team.

Strategies for sustainable development: Meaning, antecedents, and outcomes of social business models (National project – FCT CEEC - Individual)

The project Strategies for Sustainable Development was approved in 2023 under FCT's Individual Call to Scientific Employment Stimulus, for researcher **Irene Ciccarino** to develop her work at BRU-Iscte during the period 2024-2030. It aims to identify strategies that can inspire business, investment, and public policy to deliver social value and support sustainable development. The project will map social initiatives in the centre region of Portugal, describing their goals and assessing their social value, and provide a context-based narrative that highlights underlying relevant factors that can be replicated.

#SELhub: Promoting social-emotional learning, self-care and positive leadership in professionals of education (National project – FCT CEEC - Individual)

The #SELhub project was approved in 2023 under FCT's Individual Call to Scientific Employment Stimulus, for researcher **Ana Sofia Oliveira** to develop her work at BRU-Iscte during the period 2024-2030. The project focuses on teacher burnout prevention by investigating teachers' needs regarding personal and job resources, the perception of those needs from teachers and leadership teams, and the relation between these needs and teachers' well-being. It proposes to develop a digital platform based on a Social-Emotional Learning (SEL) approach for teachers and their leaders to foster teacher well-being and performance.

Publications & Awards

In 2023, BRU-Iscte researchers published **250 articles**, out of which **240** in indexed international peer-reviewed journals. In the same year, the team members assumed **127** editorial positions and memberships across various scientific journals, contributing as reviewers for **352** publications of **246** scientific journals. They also presented **137** communications at national and international conferences, resulting in **44** peer-reviewed papers in conference proceedings.

Beyond journal articles and conference papers, the research unit produced other valuable contributions, including **16** books, **55** book chapters, and **8** book editions. Additionally, the researchers authored **4** project and technical reports.

This output was honoured with **1** national and **16** international scientific awards.

BRU-Iscte Top Publications in 2023

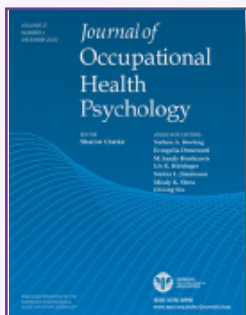

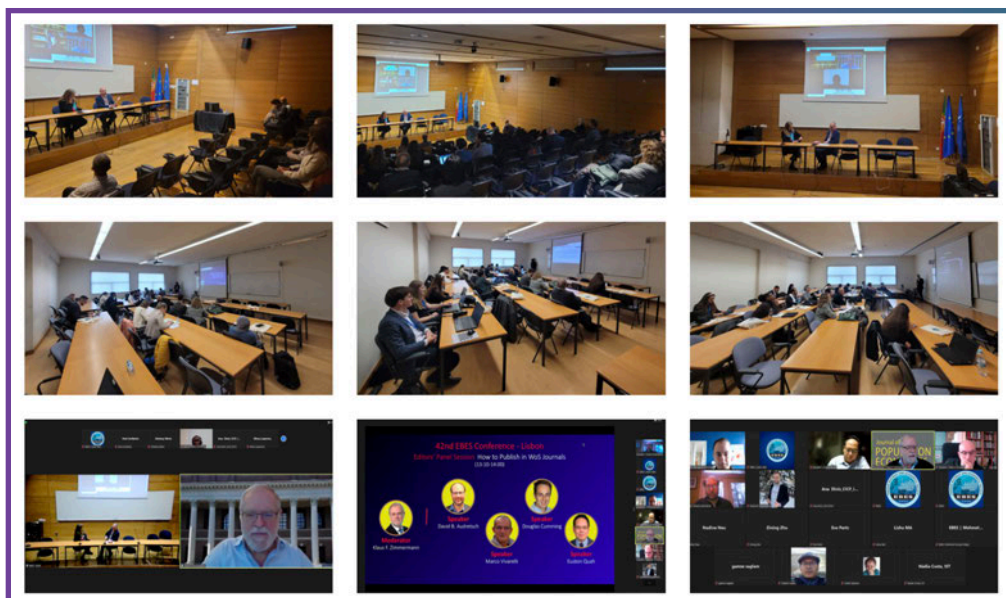
Scientific Events

In 2023, BRU-Iscte researchers were involved in the coordination/organisation of **39** scientific events (**3** national and **36** international) – from conferences to meetings, forums, colloquiums, and workshops – representing a 22% increase from the previous year. We highlight the following events, organised at Iscte with the cooperation of BRU-Iscte team members.

BRU-Iscte, in partnership with Iscte Business School and Audax-Iscte, co-organised the **10th Responsible Management Education Research (RMER) Conference** under the theme: *“Sustainable and responsible management: A decade of integrating knowledge and creating societal impact through innovation and entrepreneurship”*. The three-day event took place between September 26-28, 2023, at Iscte, marking the 10th jubilee anniversary of RMER Conferences. It focused on sharing and discussing cutting-edge theoretical and practical knowledge on responsible leadership education that promotes the advancement of 2030 Agenda and the Sustainable Development Goals. BRU-Iscte researchers **Ana Simaens** (Professor and Associate Dean for Engagement and Impact at Iscte Business School) and **Ana Patrícia Duarte** represented our research unit as programme committee members, also participating as track chairs, moderators, and authors of paper presentations. In addition, BRU-Iscte researchers **Irene Ciccarino**, **Sandra Loureiro**, and **Jorge Nascimento** were track chairs. Several other BRU-Iscte team members saw their work presented in parallel sessions, namely, **Mariana Berga Rodrigues**, **Sandra Loureiro**, **Muhammad Asim Sarwar**, **Catarina Roseta-Palma**, **Luís Miguel Simões**, **Daniela Langaro**, **Irene Ciccarino**, **João Guerreiro**, and **Patrícia Costa**. **Fátima Salgueiro**, Director of the research unit, was chair in a plenary session and co-author of a paper presentation. BRU staff, **Andreia Garcia** and **Cheila Ramalho**, provided support to the local organising committee.



The **42nd EBES (Eurasia Business and Economics Society) Conference** took place in a hybrid format on January 12-14, 2023, hosted by Iscte. More than 400 authors from 55 countries presented over 180 papers. A selection of papers is set to be published in EBES journals (Eurasian Business Review and Eurasian Economic Review) or EBES proceedings books after a peer review process, both SCOPUS-indexed publications. BRU-Iscte researcher **Sofia Vale** was a member of the organising committee and was invited to give one of the welcome speeches, was chair and discussant, and the moderator of paper sessions. BRU-Iscte research team members **Felipa de Mello-Sampayo**, **Thomas Greve**, **João Madeira**, and **Sofia Vale** presented their work in parallel sessions.



The **I Iscte Doctoral Colloquium in Accounting Research and the VIII USP Doctoral Consortium in Accounting Research** was held on July 24-25, 2023, in an online format, jointly organized by the Iscte Business School and FEA-USP (Brazil). The event was directed at PhD students from all universities to improve the quality of their theses and the impact of their research. Experienced international researchers and Iscte and USP faculty members gave lectures and participated in discussions on relevant issues in accounting research. BRU-Iscte team members **Isabel Lourenço**, **Inna Paiva**, **Rúben Barros**, **Ana Conceição**, and **Maria João Major** were part of the organising committee.



As part of the **NEXUSNET COST Action**, Iscte hosted the **1st NexusNet Training School** on May 22-26, 2023, under the theme “Nature and People in the Nexus”. The training school was an intensive coaching opportunity for COST Action participants focused on the topics of the Nexus in nature, governance and stakeholder engagement, policies, economic valuation, and innovation, having **42** participants from **13** countries joining the event. Trainers included renowned scholars, policymakers, experts from non-academic stakeholders, while trainees were PhD candidates from different scientific areas. At BRU-Iscte, **Catarina Roseta-Palma** was the local coordinator and was involved in organising the event, with the support of the Unit's staff.



BRU-Iscte organised the **First International Doctoral Colloquium in Marketing** on June 27, 2023, at Iscte, also accommodating an online audience. The event was chaired by the coordinator of the PhD in Management's Marketing specialisation, **Sandra Loureiro**, and was co-chaired by **Enrique Bigné** – professor at University of Valencia, **João Guerreiro**, **Ricardo Bilro**, and **Álvaro Dias** – BRU-Iscte researchers. The colloquium included seminars by Enrique Bigné and João Guerreiro. The format consisted of **10** presentations by PhD candidates divided into a 1st year panel (with two in-depth presentations, featuring discussion by supervisors and invited discussants), and 2 panels of 2nd and 3rd year PhD students, with 4 presentations each.



BRU-Iscte Dissemination, Knowledge Transfer & Outreach Activities

BRU-Iscte strives to translate its scientific results to practitioners, influence policymaking, and contribute for the adoption of evidence-based practices at the local, national or international administration levels. Its investigators provide research-based consulting services that can help improving managerial practices of third sector organisations, public entities, SMEs and large organisations, both nationally and internationally. Indeed, our researchers have increasingly been engaging in knowledge transfer to the wider community via a permanent effort to disseminate ideas to society, policy and practice.

In 2023, BRU researchers carried some **235** activities in terms of dissemination, knowledge transfer and outreach, in order to make more visible research accomplishments to the scientific community, professionals from the non-academic sector, public officials as well as the public at large. In addition, BRU's research has informed **43** policy papers.

Dissemination of Scientific Activity & Knowledge Transfer

In 2023, BRU-Iscte members have been responsible for **18** activities of dissemination of scientific knowledge (conferences, seminars, workshops, communications) to non-academic professionals and other stakeholders. Moreover, during the past year, our researchers were involved in **33** executive training and summer school activities, **32** contributions as expert in professional, scientific or technical committees, **2** licensed research activities (consultancies) and **1** product.

Here are some highlights of these dissemination and knowledge transfer activities.

Executive Education & Summer Schools

In 2023, **17** BRU-Iscte researchers were involved in the coordination and teaching of executive training courses, mostly within the activity of Iscte Executive Education or IPPS-Iscte, as well as in Summer/Winter Schools organised by the Iscte Business School or within the framework of ongoing projects.

For instance, **Ana Lúcia Martins**, from the Management group, organised a workshop on “*Management in Humanitarian Action*” within the Winter School organised by Erasmus+ project HumAct - Humanitarian Action: Climate Change and Displacements.

Some researchers provided training directly to companies, national and international organisations, specifically:

- **Paulo Viegas de Carvalho**, from the Finance group, provided training on emerging models of climate financing for staff of the Mozambique Government in partnership with the World Bank;
- **Sofia Vale**, from the Economics group, provided training for Higher Officers of the Military Institute officers



Licensed research, consultancies & products

Regarding consultancy activities and products by BRU-Iscte's researchers, we highlight the following activities:

- **Francisco Nunes**, from the Organizational Behavior & Human Resources group, was involved in an organisational development project based on leadership for HOTI Hotels, one of the major hospitality operators in Portugal, currently in an expansion phase. The project aimed to prepare top leadership (Department Directors and Hotel Directors) to instigate processes for the improvement of organisational performance, allowing for the desired expansion, while nurturing the company's identity. This 1-year project encompassed a diagnostic of cultural and leadership factors, training actions as well as the creation of personal development plans for the leader identity.



- **Paulo Viegas de Carvalho**, from the Finance group, produced a forecasting model on companies' viability. This product is distributed by Informa D&B and allows to have the perspective of a company created for less than 12 months to continue its activity 5 years after its creation. It is therefore an indicator derived from long-term viability forecasting models.

Expertise in Technical and Scientific Committees

In recognition of their scientific outputs, several BRU researchers have been invited to provide expertise in various technical, professional and scientific committees.

In terms of scientific societies, we highlight the following prestigious positions held by our researchers:

- **Irene Ciccarino** (Management) - Entrepreneurship Section Chair of GBATA – Global Business and Technology Association;
- **Maria de Fátima Salgueiro** (Data Analytics) - President of the Fiscal Council of CLAD – Portuguese Association of Data Classification and Analysis.

In 2023, our researchers have also been providing their expertise to corporate and government bodies alike, such as:

- **Sílvia Silva** (OBHR) - Coordinator of the Green Paper Committee for the Future of Safety and Health at Work – Secretariat of State for Labour;
- **Teresa Grilo** (Management) - Member of the working group for assessing training needs in medicine for the next decade – Ministry of Science, Technology & Higher Education and the Ministry of Health;
- **Maria da Conceição Figueiredo** (Data Analytics) - Observatory of Youth Employment, in collaboration with IEFP, the government agency for employment;
- **Maria José Sousa** (Management) – Empreend – Portuguese Association of Entrepreneurship.

Scientific Dissemination Activities

With regards to dissemination activities geared to non-academic professionals, we highlight the following initiatives from BRU-Iscte researchers in 2023:

- **Ana Lúcia Martins**, from the Management group, was invited to contribute to EEA project Fish2Fork by intervening in a workshop and seminar organised with stakeholders in Bergen, Norway, with a talk on *“Operations Management for fish: The impact of the use of technology in the sustainability of fish supply chain management”*;
- **Aristides Ferreira**, from the Organization Behavior & Human Resources, participated in the 1st International Conference on Healthy Working and Learning Environments, discussing actions and recommendations for the promotion of biopsychosocial and environmental health at work, within a panel on *“Priorities in the promotion of healthy working and learning environments”*;

- Research assistants from the Management group, **Margarida Lopes** and **Helena Almeida**, presented the ImAFUSA project - Impact and capacity Assessment Framework for U-space Societal Acceptance - at the SESAR Innovation Days. SESAR is the technological pillar of the EU's Single European Sky policy and a key enabler of the European Commission's Sustainable and Smart Mobility Strategy, and its Innovation Days provides a forum for the ecosystem's stakeholders;
- **Catarina Roseta Palma**, from the Economics group, participated in the NEXUSNET Forum of Stakeholders with a presentation on "*Planting Water: the Art of Harvesting the Sun*", in collaboration with the Association Terra Sintrópica.
- **Maria João Major**, from the Accounting group, participated in Protótipo workshop on the Future of Accounting with a talk on ESG (Environmental, Social and Governance) and non-financial reporting;
- **Ricardo Bilro**, from the Marketing group, contributed to the Sustainable Value Creation Summit with a presentation on "*How to create value in tourism through AI & XR*".

BRU-Iscte in the Media

He presented a talk on “*The role of solid, transparent and accountable public finance*”.

Luciana Barbosa, from the Finance group, contributed to the SEED project of the City of Lisbon (Awareness for Entrepreneurship and Innovation), by providing her insights on the issue of financial literacy.

Paulo Bento, from the Management group, coordinated the 1st Hackathon of Ecopreneurship, which took place on November 2023 with the aim of devising creative solutions that promote sustainability and innovation.

Susana Tavares, from the Organizational Behavior & Human Resources group, was an invited keynote speaker at the Digital with Purpose Global Summit, presenting a communication on “*Sustainability and gender balance at work*” in the session “*Women in Tech driving Sustainability*”.

Two BRU-Iscte researchers, **Márcia Santos** (Management group) and **Vanessa Oliveira** (Organizational Behavior & Human Resources group) took part in the 1st Cycle of Sessions on Social Economy: IN-PACT as discussants of the round table “*Prospering Together: A Round Table for Social Economy Research*”, which took place on October 31, 2023, in Iscte. The aim of this occasion was to bring together management research in Social Economy and the needs of Organisations in a debate and exchange of ideas.

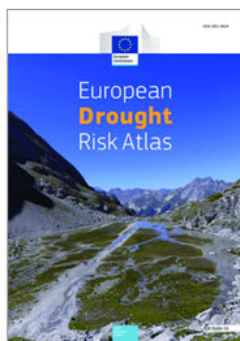

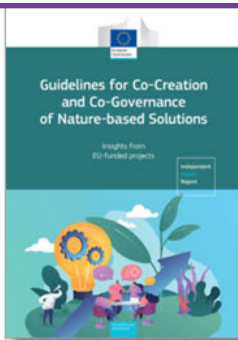

UAMschool4cities: Urban Air Mobility School for Cities (2022-2024)

UAMschool4cities is an Erasmus+ coordinated by BRU-Iscte researcher **Sofia Kalakou**, with BRU-Iscte researchers **Nelson Ramalho** and **Margarida Lopes** as part of the team. The project aims to develop and launch a MOOC (massive open online course) to build the capacity of future employees interested in entering the Public Administration sector.

In 2023, the key achievements of the projects were:

- In September, the project published a press release highlighting the progress made in creating a specialized training programme for Local Authority employees and reporting a survey conducted in three market countries (Portugal, France, and Greece). The survey aimed to understand current knowledge and interest in UAM among public sector professionals and identify areas for improvement and had 1003 valid responses from local authorities' staff.
- Between October 10-12, the UAMschool4cities was represented by **Margarida Lopes** (research fellow in the project) in the 2023 edition of the Portugal Smart Cities Summit held at the Feira Internacional de Lisboa (FIL), Portugal.



XpanDH: Expanding Digital Health through a pan-European EHRxF-based Ecosystem (2023-2024)

XpanDH is a HORIZON CSA coordinated by BRU-Iscte researcher **Henrique Martins**. The project aims to build capacity in individuals and organisations with the aim of creating, adapting, and exploring the use of interoperable digital health solutions through a shared adoption of the European electronic health record exchange format (EEHRxF) across the EU.

In 2023, the key achievements of the project were:

- Between February 15-16, the XpanDH consortium organised an in-person kick-off meeting in Lisbon (Portugal).
- Between May and September, the project launched three webinars – explaining what is the EEHRxF, why it matters, and on building the European Health Data Space. The webinars were joined by hundreds of panellists, covering insights from health managers, researchers, and policymakers.



TOURSUS-EU: Assessing Tourism Sustainability in the EU Region – A Quantitative Approach (2023-2025)

TOURSUS-EU is an MSCA/Post-Doc Fellowships coordinated by BRU-Iscte researcher **Sandra Loureiro**. The TOURSUS-EU proposal aims to contribute to the definition and transition to a more sustainable tourism model, introducing a new approach to measuring the impact of mass tourism on the economy and society by analysing data from important UNESCO World Heritage tourist destinations (Venice, Lisbon, and Split). The proposal is based on the use of state-of-the-art knowledge and analytical methods – Dynamic Dashboard Models, Time Series Analysis, Multi Criteria Decision Analysis and Big Data Analysis – to develop an innovative structured approach to assessing and improving the sustainability of tourism.



In July 2023, BRU-Iscte welcomed its first MSCA post-doctoral fellow. **Dr. Ana Gardasevic** from Montenegro started working in July to carry out the project, supervised by **Sandra Loureiro** (coordinator of the Marketing research group).



ImAFUSA: Impact and capacity Assessment Framework for U-space Societal Acceptance (2023-2026)

ImAFUSA is a HORIZON RIA/SESAR 3JU coordinated by BRU-Iscte researcher **Sofia Kalakou**, with BRU-Iscte researchers **Catarina Marques, Fernando Ferreira, João Guerreiro** and **Margarida Santos** as part of the team. The project aims to study factors influencing Urban Air Mobility (UAM) acceptance in urban areas, and deliver a framework to assist local authorities, U-space stakeholders, and users in deploying socially acceptable and beneficial UAM services in cities.



In 2023, the key achievements of the project were:

- On October 4, the ImAFUSA kick-off meeting took place at the TU-Delft, in the Netherlands.
- On October 10, the project participated in the 2nd Annual Conference of the SESAR 3 Joint Undertaking in Brussels (Belgium), represented by coordinator **Sofia Kalakou** (from BRU-Iscte) and Chariton Palaiologk (from Future Needs).
- Between November 27-30, the ImAFUSA participated in the 13th SESAR Innovation Days (SIDs), in Seville (Spain), and presented a poster at the exhibition venue.



EWRI: Exploitative working relationships: Impact on employees' health and behaviours (2023-2026)

EWRI is an FCT IC&DT coordinated by BRU-Iscte researcher **Sandra Costa**, with **Sofia Oliveira** and **Tiago Rôxo Aguiar** as part of the team. The project focuses on exploitative working relationships in developed countries, looking particularly into the perceptions of exploitation and their consequences for employees' health and work-related behaviours. Findings will have policy implications and will provide evidence-based recommendations to facilitate the minimization of these perceptions and raise awareness of the deleterious consequences of such exploitative working relationships.



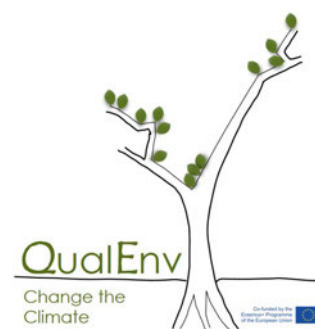
In 2023, two grants were secured:

Projects coordinated by BRU-Iscte & with BRU-Iscte support concluded in 2023

QualEnv: Change the Climate – Assuring the Quality of Environmental Strategies in Latin-American Higher Education (2020-2023)

QualEnv was an Erasmus+ led by BRU-Iscte, with researcher **Catarina Roseta Palma** as coordinator and **Ana Simaens** as part of the team. The project also involved Iscte research unit ISTAR-Iscte as well as Iscte's Quality Office. The QualEnv project aimed to promote the cooperation for innovation and the exchange of good practices between Latin-American and European higher education institutions, addressing the creation and strengthening of quality assurance mechanisms in environmental management, in a way that is consistent with international standards. The project was based on the transfer of experiences, skills, and competences among leading universities in sustainability and quality management, as well as high-value educational and training content that can accelerate progress in the implementation of SDGs in Latin-American universities.

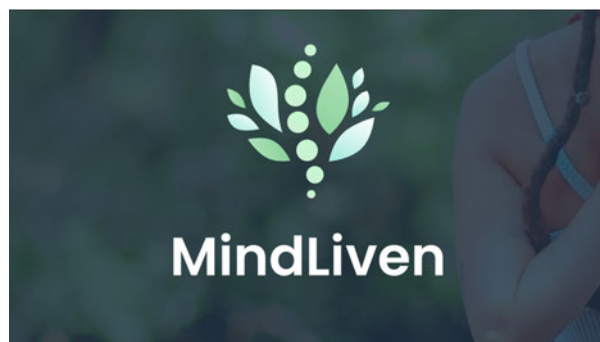


Between April 26-28, 2023, the final meeting of the QualEnv project took place at the Pontifical Catholic University of Rio Grande do Sul, in Porto Alegre (Brazil), featuring conferences in Portuguese, Spanish, and English. In this occasion, the consortium discussed the project's challenges and milestones, and legacy.



MINDLIVEN: Mindfulness-in-Nature Based Training through Virtual Environments (2020-2023)

MINDLIVEN was an Erasmus+ led by University of Verona, with BRU-Iscte researcher **Sílvia Silva** as local coordinator, and BRU-Iscte researchers **Patrícia Costa** and **Sara Ramos** as team members. The project focused on preventing and addressing workplace stress, through the development of a set of Mindfulness-in-Nature-based practices (MiNBP) supported by an online platform with communication tools and additional resources. The aim of the platform was to facilitate the transfer of learning into the workplace and to create a support community, paired with training and gamification techniques organised into different modules.



During the period April-May 2023, Multiplier Events took place in 5 countries (Italy, Spain, Portugal, Greece, Poland), promoting the project's main results: the MINDLIVEN MiNBP Contents, the MINDLIVEN Online MiNBP Platform, and the MINDLIVEN Policy Report. On May 19, 2023, Iscte hosted the project's final meeting, in which MINDLIVEN partners talked about the findings, reflections, and discussions from the testing process of the educational platform.



INOVMINERAL4.0: Advanced Technologies and Software for Mineral Resources (2020-2023)

INOVMINERAL4.0 was a PT2020 project led by CEI - Companhia de Equipamentos Industriais (Portugal), with BRU-Iscte researcher **João Vilas-Boas** as local coordinator. The aim of the project was to innovate and reorient the industrial models that sustain the Mineral Resources sector through the development of advanced technologies, new products, and software that address the entire value chain: prospecting and mineral research, integrated valorisation of mineral resources, and gains in market share.

The main activities of the project in 2023 were the following:

- In February, the Portuguese Prime Minister and other high representatives visited Solancis SA, one of the leading companies of the INOVMINERAL4.0 consortium, reinforcing the commitment to the Stone by Portugal Sustainable Agenda.
- **Dr. Agostinho Manuel Antunes da Silva**, CEI's co-founder and CEO, presented the objectives, agenda, developments, and results of the INOVMINERAL4.0 project activities at the International Symposium: New Construction with Stone. This event took place between March 1 and 2, at the Faculty of Engineering of the Universidade da Beira Interior (UBI).



ATHENA: University Goes Digital for a Sustainable Global Education (2021-2023)

ATHENA was an Erasmus+ coordinated by BRU-Iscte researcher **Maria José Sousa**, with BRU-Iscte researchers **Álvaro Rosa, Álvaro Dias, João Guerreiro, Leandro Pereira, Pedro Fontes Falcão, Renato Lopes da Costa, Renato Pereira**, and **Teresa Grilo** as part of the team. The project aimed to develop the digital competences of university lecturers, strengthening their response to the challenges facing higher education institutions currently and in the future. The project sought to foster cooperative learning environments, making them transformative and inclusive through the adoption of new technologies such as e-learning, gaming platforms, virtual and augmented reality, modelled systematically to activate key competences in digital learning.

In 2023, the 4th and final Transnational Project Meeting was held in Portugal at Iscte, on February 9 and 10. During this meeting, all ATHENA partners discussed results and shared outputs of the products. The partners also took the time to exchange on the project's sustainability, the final report, and the financial balance. The final event was also the opportunity to launch the foundation for new initiatives.



iNSPIRE: Innovation for Social Entrepreneurship (2021-2023)

iNSPIRE was an Erasmus+ led by the Association Culturelle des Jeunes Turcs de Bar le Duc (France), with BRU-Iscte researcher Maria José Sousa as local coordinator, and BRU-Iscte researchers **Leandro Pereira, Marjan Jalali, Renato Lopes da Costa**, and **Sofia Vale** as part of the team. The project also involved researchers from IT-Iscte and DINÂMIA'CET-Iscte.



The main activities of the project in 2023 were the following:

- Between June and September, the iNSPIRE Social Entrepreneurship Training took place in Turkey.
- In July, the Inspire Network webinar on Social Impact meeting took place (online).
- In September, the project also hosted a social entrepreneurship-themed workshop in Dublin (Ireland).
- Between September and October, Multiplier Events took place in Portugal (at Iscte) and Turkey, some of which promoting editions of the iNSPIRE Social Entrepreneurship Competition.



ECCEPFIE: European Citizenship Common Education Program for Integrated Europe (2021-2023)

ECCEPFIE was an Erasmus+ led by Voices of the World (Belgium), with BRU-Iscte researcher **Maria José Sousa** as local coordinator. The project also involved Iscte research units CIES-Iscte and ISTAR-Iscte. The project aimed to create a common and inclusive curriculum for students aged 14-18 focused on cultivating EU citizenship education, adopting EU values, raising awareness of European common culture, and having a European identity among young students. The ECCEPFIE project worked to ensure that students got support in school within the teacher-parent triangle, with in-school and out-of-school activities, communication, cooperation, interaction with their European peers, and took responsibility together. An e-book was designed and improved gradually for teachers to use in their execution of European citizenship and EU club training.

The main activities of the project for 2023 were:

- In February, the project was presented at the national exhibition “*Project Fair 2023*” in Klaipėda (Lithuania). The presentation included all national schools and served to introduce and encourage them to use the open education resources designed during this project.
- On March 9-10, the project was showcased at the XVI Educational Fairs at Lublin Exhibition Centre (Poland).
- On April 26, 2023, the last dissemination event of the ECCEPFIE was a conference held in Brussels (Belgium), in the European Parliament. A Member of the European Parliament (MEP) was present, Salima Yenbou, as well as Prof. **Maria José Sousa** (Bru-Iscte). Representatives of all partner schools were also present, and the mobile app launched.



Digi-SOC: Digital Skills and Cross-Domain Entrepreneurship for Societal Challenges (2021-2023)

Digi-SOC was an Erasmus+ led by University of Economics in Katowice (Poland), with BRU-Iscte researchers **Maria José Sousa, José Pedro Dionísio**, and **Ilídio Lopes** as team members. The local coordinator was Pedro Sebastião from IT-Iscte. Digi-SOC focused on developing higher education curricular material addressing digital skills and cross-domain entrepreneurial competencies of university students, equipping them to confront societal challenges. The main outcome was a pedagogical and informative handbook detailing the results achieved.



The main activities of the project in 2023 were:

- Between May 17-21, Digi-SOC partner University of Bologna (Italy) hosted the “building your own competencies within an international, digital and entrepreneurial environment by academic knowledge workshop”, in which students designed a game that addresses different facets of the societal challenges of transition while allowing the player to experiment entrepreneurial competences.
- On November 9, Digi-SOC partner Universitat Antònoma de Barcelona, Faculty of Economics and Business, hosted a conference on innovation and teaching quality with the title “Digital Skills and Cross-Domain Entrepreneurship for Society Challenges”, welcoming the eight other European universities partner to share their experiences in promoting entrepreneurial mentality and developing digital skills in students.
