The approved proposal shall receive funding up to €240.000 each, for a maximum period of 36 months.

All applications must be submitted in English through an electronic form at Balcão 2020.

The *IV Congresso Nacional da Formação Profissional* was organized by Forma-te, ISCTE-IUL, McDonald's and TAP Portugal.

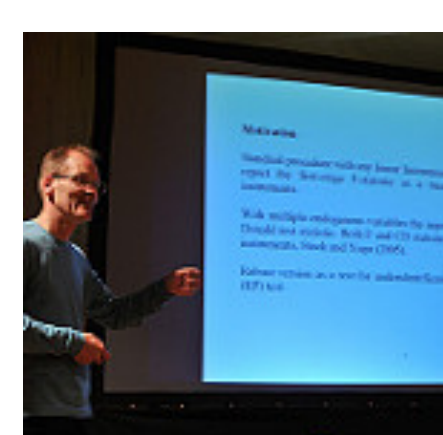
